Parent/Legal Guardian Agreement

- Your child's card is for your child's use only, and your child must be present to get their card.
- Your child's library record (like yours) is private by law. For children 8 and up, the library cannot tell you what your child has checked out, except when a fee is owed.
- The Library cannot limit access to any items in the library, including computers, for your child. Your child can use computers even if they do not have a library card.
